PREREQUISITES AND RECOMMENDATIONS

In order to enroll in the subject Undergraduate Dissertation, the student must, in accordance with the Guidelines for the Development of Undergraduate Dissertation for the Grados (Bachelor's degrees) of the Faculty of CC. Economic and Business of the UGR:

- Have passed at least the following number of credits according to the Grado (Bachelor's Degree) that is taken (according to the Verification Report):
 - Grado (Bachelor's Degree) in Economics: 72 ECTS credits of basic course and 90 compulsory credits.
- Have passed all the first year subjects.
- At the time of registering the TFG, the student must register the total of the credits that are missing to complete the Grado (Bachelor's Degree).

BRIEF DESCRIPTION OF COURSE CONTENT (According to the programme's verification report)

- In accordance with the objectives and contents established in the subjects, which are compulsory and basic training, students must carry out, defend (where appropriate) and present a work-report that implies the applicability and integration of the training content received from generic skills fundamental acquired throughout the training, and developing the skills and abilities of a professional with this study profile.
- As a general modality, the student will prepare and present a portfolio of competencies.
- The portfolio of competencies is a learning, monitoring and evaluation tool that allows the collection, registration and presentation of evidence by the student to show the level of achievement of the generic competencies associated with the Grado (Bachelor's Degree). This tool also enables interaction with your academic tutor. The generic competences constitute a complement to the theoretical and practical knowledge of the subjects studied and include the abilities, competences and skills that all graduates must have to enter the labor market. The portfolio provides a complementary information to that reflected in the academic record, offering a more complete view of the learning carried out by the student throughout the Grado (Bachelor's Degree) studies.
- Likewise, the TFG report may be associated with development cooperation projects of the CICODE (Centre for Development Cooperation Initiatives), the development of business projects of the program proposed by UGR-Entrepreneur of the University of Granada and



monographic works directed by professors of the Center, provided that the procedure established by the Faculty is followed.

ORDINARY EXAMINATION DIET

- The TFG will be evaluated by the tutor taking into account the evidence and memory presented either in the Skills Portfolio mode or in the other possibilities provided. The evaluation system must follow the rubric approved by the Academic Committee, on a total score of 10, which establishes the indicators to be assessed and their corresponding levels of achievement. That rubric can be consulted in the Didactic Guide of the subject,



- as well as in the Guide of General Orientations of the TFG - Other Modalities different from the Portfolio, which will be published on the website of the Degree and the Faculty.
- The tutor will inform the student of his/her grade, along with the date, time and place of the review of the grades.
 - In the event that the tutor recommends the qualification With Honors (A+), the defense of that TFG before a Court in public session will be mandatory, according to the procedure established in the Development Guidelines of the Grados (Bachelor's Degrees) of the Faculty of Economic and Business Sciences.
 - As stipulated in the UGR Guidelines on the Development of the TFG Subject, the TFG grade cannot be incorporated into the student's academic record until the rest of the credits of the degree have been approved.

EXTRAORDINARY EXAMINATION DIET

The student will hold mandatory collective and individual face-to-face meetings with the tutor assigned to them. In it, the general lines of work will be defined, as well as the work calendar will be established, in which the different questions that arise in the development of the work will be raised and the report and the various evidences that are required will be completed. The student will make a report or memory based on the evidence collected in their portfolio or in the work carried out justifying the degree of achievement of each of the competencies that it reflects, in addition, they may make oral presentations, if the tutor considers it appropriate. That report will be presented for evaluation within the terms established for this purpose by the Faculty.
